#### Note:

- (1) Out of total 20 candidates called for interview, 16 candidates remained present. The Candidate bearing E No. 11, Dr. Pareshkumar Indubhai Andharia( Code No. EAT) remained present for verification of certificates, but left before he was called for the interview. Hence remaining 15 candidates were interviewed for the posts.
- (2) There were total 15 posts, 08 post for General Category, 04 post reserved for SEBC Category, 02 post reserved for ST category and 01 post reserved for SC Category. The commission did not consider any candidate suitable for the posts.
- (3) With regards to women reservation as provided for, in the Government Notification GAD No. GS/97-13-CRR/1096/2213/G-2 Dated 9th April, 1997 and GAD Circular No. CRR/1096/2213/G-2, Dated 22nd May, 1997, 03-woman candidates (02 of General Category and 01 of SEBC Category) were required to be selected. As against this, no woman candidate has been found suitable for the post.
- (4) The Commission regrets its inability to recommend any candidate suitable for the post.
