Note:- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (5) Candidates belonging to Other Backward Classes included in this list who are required to produce Non-Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents. SC/ST candidates shall produce Community Certificate obtained from Revenue Authorities not below the Rank of Tahsildar. Candidates in the Main List who fail to produce the required NCLC/Caste Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates. As regard to such candidates in the supplementary lists of backward castes, SC/ST, their register numbers will be deleted from the short list without further notice, if they fail to produce NCLC/Caste Certificate

Note :- (6) Copy of answer scripts of the OMR Test held on **03/11/2016** will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of the Ranked List.
