**ORDER**

**Terms and conditions:**

1. The appointment is purely temporary in the usual time scale of pay stated above with usual D.A. and other allowances as admissible by the Government from time to time against the existing vacancy subject to result of W.P.(C) No.1273 of 2014. Their services can be terminated at any time without assigning any reason/cause thereof as per Rule 8(2) & (3) of Orissa District Subordinate Courts Non-Judicial Staff Services (Method of Recruitment and Condition of Service) Rules, 2008 and amendment Rule, 2010.
2. They are to remain on probation for a period of two years from the date of their joining in service, provided that if during the period of probation, their work or conduct is found unsatisfactory or it appears that they are likely to become inefficient, the District Judge may either discharge them from their service or extend the period of probation for such further period as deems fit as per Rule 8(1) of Orissa District Subordinate Courts Non-Judicial Staff Services (Method of Recruitment and Condition of Service) Rules, 2008 and amendment Rule, 2010.
3. No T.A. shall be allowed for their joining in their respective posts.
4. Their appointment shall be cancelled if they fail to report joining at their place of posting on the scheduled date and time with relevant documents/ testimonials as mentioned below.

5. The seniority of the candidates for the above posts inter se shall be determined in accordance with the position secured by them in the competitive examination held in a particular year as per Rule 9(I) of Orissa District Subordinate Courts Non-Judicial Staff Services (Method of Recruitment and Condition of Service) Rules, 2008 and amendment Rule, 2010.
6. They are directed to report their joining at their respective place of posting in the forenoon of 18.08.2017 positively along with the following documents or to report their joining in their new assignment as directed by the concerned Presiding Officer after their joining:-
  - a. Original Educational Qualification Certificates for verification.
  - b. Medical fitness Certificate from a registered Medical Practitioner not below the rank of an Assistant Surgeon of Govt. Hospital in the prescribed form.
  - c. Two Character Certificates from two different Gazetted Officers.
  - d. A declaration to the effect that he/she has not more than one spouse living, if married.
  - e. An Undertaking in shape of an Affidavit that the financial benefit availed on regular basis shall be realized as per the applicability of the result of W.P.(C) No.1273 of 2014.

Inform all concerned and issue appointment letters separately through Regd. Post in their respective given address.

This Order be published in the District Court web site. The candidate who fails to receive the appointment letter in due time before the date of joining in case of postal delay is advised to collect the duplicate copy of the Appointment letter from District Office on 17.08.2017 during office hour.
