PROVISIONAL SELECT LIST

1. In Pursuance to the Notification dated:15.12.2016 cited at reference-1, recruitment process to fill up 41 posts of Police Sub-Inspector (State Intelligence) (Men & Women) including Inservice was initiated and after completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009 & 2016, Provisional Select List cited at reference-2 was published on 30.05.2017.
2. Whereas, after publishing Provisional Select List for the above posts, selected candidates were subjected to Medical Examination before duly constituted Medical Board. Two candidates who were selected for the post of Police Sub-Inspector (State Intelligence) viz., Sri. Sanjeev Gattaraki, bearing Roll No.2502270 & Sri Ashok Malabagi, bearing Roll No.2506333 were declared unfit by the Medical Board vide report cited at reference-3. Accordingly, the candidature of the above two candidates namely Sri. Sanjeev Gattaraki & Sri Ashok Malabagi, was cancelled vide order No.52/Rect-2/2016-17, dated:19.08.2017.
3. Due to the cancellation of the candidature of Two candidates namely Sri. Sanjeev Gattaraki & Sri Ashok Malabagi, two posts in Police Sub-Inspector (State Intelligence) have remained unfilled. In order to fill up the two posts this Provisional Select List is being published with the following conditions.
 - a) This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.

- b) The fact that the name of the candidate figures in this list does not give him/her any legal right for appointment to the post which will be dependent on the aforesaid conditions.
- c) This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
