**POSTS INCLUDED IN CCS-I EXAMINATION (GROUP I SERVICES)**  
**(Main Written Examination)**

A List III containing the register numbers of 5 candidates provisionally admitted to Certificate Verification (Phase III) for the **POSTS INCLUDED IN CCS-I EXAMINATION (GROUP I SERVICES)** was published in the Commission's website on 11.09.2017 based on results of the written examination conducted by the Tamil Nadu Public Service Commission on 29.07.2016, 30.07.2016 and 31.07.2016.

During the 3<sup>rd</sup> Phase of Certificate Verification held on 18.09.2017, the application of 1 candidate has been rejected. After the 3<sup>rd</sup> phase of Certificate Verification, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:2 against one unfilled vacancy in the category of SC(W)(PSTM) in the post of Deputy Superintendent of Police (Category I) in the Tamil Nadu Police Service included in CCS-I Examination (Group I Services). The Oral Test will be held on **03.10.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. The candidates should come to office of the Tamil Nadu Public Service Commission with all original certificates in support of the claims made in their online applications. Individual intimation regarding the date and time of the Oral Test will be sent to the candidates separately:-

**Notes:**

1. **Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.**
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Main Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, PSTM etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to Oral Test.
3. The Candidates who have appeared for the Main Written Examination and whose register numbers are not found in the above list have not been admitted to the Oral Test.
4. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP Nos. 20875/2016, 26205/2016, 26572/2016 and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
