PROVISIONAL SELECT LIST

1. In Pursuance to the Notification dated: 15.09.2016 cited at reference-1, recruitment process to fill up 28 posts of Police Sub-Inspector (Wireless) including in-service was initiated and after completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009 & 2014, Provisional Select Lists cited at reference-2 were published on 12.01.2017, 07.04.2017 & 17.06.2017.

2. Two candidates who were selected for the post of Police Sub-Inspector (Wireless) Sri. Shreeshail Babu Talwar, bearing Roll No:7051048, and Sri Anil Kumar D.M, bearing Roll No:7051658 vide representation cited at reference (3) have expressed their unwillingness to join the post. Accordingly, considering the request of the above two candidates their candidature was cancelled vide order No.45/Rect-2/2016-17, dated:26.08.2017.

3. Apart from this, in the letter cited at reference-4 it has been stated that two candidates who were selected for the post of Police Sub-Inspector (Wireless) viz., Sri. Bhahubali R Akkoli, bearing Roll No:7051118, and Kum. Nafisabi Imamsab Attar, bearing Roll No:7051372 have remained absent for the Medical Examination and has further requested to consider the candidature of the other candidates in place of the above candidates. Accordingly, considering the absence for medical examination, the candidature of the above two candidates were cancelled vide order No.45/Rect-2/2016-17, dated:26.08.2017.


4. Whereas, due to cancelling the candidature of four candidates namely Sri. Shreeshail Babu Talwar, Sri Anil Kumar D.M, Sri. Bhahubali R Akkolli and Kum. Nafisabi Imamsab Attar, four posts in Police Sub-Inspector (Wireless) has remained unfilled. In order to fill up the four posts this Provisional Select List is being published with the following conditions.

- This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
- The fact that the name of the candidate figures in this list does not give him/her any legal right for appointment to the post which will be dependent on the aforesaid conditions.
- This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
