PROVISIONAL SELECT LIST

1. In Pursuance to the Notification dated:09.11.2016 cited at reference-1, recruitment process to fill up 59 posts of Sub-Inspector of Police (Civil) (Men & Women) including Inservice in HK & NHK was initiated and after completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009 & 2016, Provisional Select Lists cited at reference-2 were published on 20.05.2017 & 31.05.2017.


2. Whereas, after publishing Provisional Select Lists for the above post, selected candidates were subjected to Medical Examination before duly constituted Medical Board. The candidate who was selected for the post of Sub-Inspector of Police (Civil) viz., Sri. Vinod Doddalingappanavar, bearing Roll No.2201736 was declared unfit by the Medical Board vide report cited at reference-3. Accordingly, the candidature of the above candidate namely Sri. Vinod Doddalingappanavar was cancelled vide order No.54/Rect-2/2016-17, dated:21.08.2017.

3. Due to the cancellation of the candidature of the candidate namely Sri. Vinod Doddalingappanavar., one post in Sub-Inspector of Police (Civil) has remained unfilled. In order to fill up the one post, this Provisional Select List is being published with the following conditions.

- a) This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.

- b) The fact that the name of the candidate figures in this list does not give him/her any legal right for appointment to the post which will be dependent on the aforesaid conditions.
- c) This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
