PROVISIONAL SELECT LIST

1. In Pursuance to the Notification dated: 15.09.2016 cited at reference-1, recruitment process to fill up 90 posts of Armed Reserve Sub-Inspector (CAR/DAR) (Men) including in-service was initiated and after completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009 & 2014, Provisional Select Lists cited at reference-2 were published on 15.06.2017 & 17.06.2017.

2. Whereas, after publishing Provisional Select List for the above posts, selected candidates were subjected to Medical Examination before duly constituted Medical Board. Two candidates who were selected for the post of Armed Reserve Sub-Inspector (CAR/DAR) viz., Sri. Gurumurthy K., bearing Roll No.9304437 and Sri Nasir Mahammedsahab Mujawar, bearing roll No:9300829 were declared unfit by the Medical Board vide report cited at reference-3. Accordingly, the candidature of the above two candidates namely Sri. Gurumurthy K and Sri Nasir Mahammedsahab Mujawar, were cancelled vide order No.44/Rect-2/2016-17, dated:11.09.2017.

3. Apart from this, in the letter cited at reference-4 it has been stated that two candidates who were selected for the post of Armed Reserve Sub-Inspector (CAR/DAR) viz., Sri. Shafik, bearing Roll No:9303180 and Sri. Ramesha U., bearing Roll No:9302257 have remained absent for the


Medical Examination. Accordingly, considering the absence for medical examination, the candidature of the above two candidates were cancelled vide order No.44/Rect-2/2016-17, dated:11.09.2017.

4. Whereas, due to cancelling the candidature of four candidates namely Sri. Gurumurthy K., Sri Nasir Mahammedsahab Mujawar, Sri. Shafik, and Sri. Ramesha U, four posts in Armed Reserve Sub-Inspector (CAR/DAR) have remained unfilled. In order to fill up the four posts this Provisional Select List is being published with the following conditions.

- This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
- The fact that the name of the candidate figures in this list does not give him/her any legal right for appointment to the post which will be dependent on the aforesaid conditions.
- This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
