2. Final Merit List has been prepared on the basis of Performance in CBM Examination held on 16.07.2017.
3. Scores in the CBM Examination of those candidates who did not appeared for the Document Verification or who do not fulfilled all the Criteria as per the Notice of Recruitment, have not been considered.
4. In case two or more candidates secure same Marks in the CBM Examination, the tie cases have been resolved by the following procedures:-
  - i. In case of candidates securing equal marks, their merit has been decided on the basis of age, the older in age being placed higher in rank i.e. the candidate older in age has been given preference.
  - ii. If the tie cases still remain, ranking has been decided by using the alphabetical order of the first names of the candidates i.e. a candidate whose first name begins with the alphabet which comes first in the alphabetical order gets preference.
5. The candidatures of the above candidates are provisional.
