In pursuance of Rule 32 of J&K Public Service Commission (Conduct of Examinations) Rules, 2005 read with Rule 40 of J&K Public Service Commission (Business & Procedure) Rules, 1980, the candidates as per Annexure-A to this notification are hereby declared to have qualified for the Oral Test for the posts of Lecturer 10+2 Bio-Technology in School Education Department on the basis of their performance in the Written Test which was held on 12.06.2016.

Note:

- i. The candidature of candidates shown in **Annexure -A** is purely provisional;
- ii. Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the Oral Test/Interview subject to the condition that they are within the prescribed age limit on the cut off date.
- iii. The candidates who qualified the Written Test are advised to submit copy of their online application form along with fee receipt within 07 days at J&K PSC office, Solina Srinagar/Resham Ghar Colony Bakshi Nagar Jammu or send by post to the address of “**Controller of Examinations, J&K Public Service Commission, Solina, Srinagar**” by registered post and only such identified documents shall be received as have been posted by or before 04.10.2017 and delivered in the Commission by 06.10.2017.
- iv. Candidates possessing Degrees through distance mode shall have to produce a proof of having degree within the purview of Government

Order No. 252-HE of 2012 dated: 30.05.2012 from Competent Authority of the concerned University.

- v. The candidates shall produce their original certificates/testimonials on the date of oral test/Interview.
- vi. Oral Test/Interview of the eligible candidates shall be held w.e.f **10.10.2017**. However, the detailed schedule for Oral Test/interview will be notified separately.

This is subject to the outcome of writ petition, if any, pending disposal before any competent Court of Law.
