The individuals are directed to furnish **Physical Fitness Certificate obtained**from not below the rank of Civil Surgeon at the time of joining duty and in case of the differently-abled candidates, a certificate, with regard to the nature of

disability, percentage of disability and their capacity to perform the duty, from the District Medical Board should be submitted by the individuals either at the time of joining duty or within one month from the date of joining duty.

The individuals are informed that this provisional Appointment is made based on their claim and the Certificates submitted by them and if any of their claim, are found to be false, their selection and appointment will be cancelled without any further notice.

The individuals are further informed that their appointment under rule 16 (a) (i) of T.N.J.M.S to the post borne on the cadre of service shall not be regarded as a probationer or shall not be entitled by reason only of such appointment to any preferential claim to future appointment. It is further informed that the services of such a person in the post shall be liable to be terminated by the Appointing Authority at any time without notice and without any reason being assigned.
