**POST GRADUATE TEACHER (HISTORY) (FEMALE)  
IN DIRECTORATE OF EDUCATION  
UNDER POST CODE 139/2012**

The DSSSB vide result notice No 484 dated 15.03.2017 and result notice No 518 dated 12.06.2017 had declared the result of 56 candidates for the post of *Post Graduate Teacher (History) (Female)* in Directorate of Education under **Post code 139/2012**.

The representation dated 03.04.2017 filed by a candidate namely Ms Sunita Kumari having Roll number 26000851 was examined by the Board and in view of the fact that the candidate has acquired her MA qualification after the cutoff date, Board has decided that her candidature shall remain as rejected in postcode 139/12. An OBC vacancy which was kept as withheld on account of her representation is hereby released

The representation dated 05.07.16 of the candidate namely Ms Suman having roll number 26002788 for consideration of her candidature in postcode 139/12 was examined. It has been ascertained that candidate has applied for the post of PGT (History) against the advertisement No 02/2012 vide ID No 2706714. In the available data her candidature was inadvertently mentioned in postcode 138/12 which was for the post of PGT (History) (Male). In view of the fact that Ms Suman has applied for the post of PGT (History) and Ld CAT order dated 23.05.2017 in OA No 1795/2017 in the matter of Suman vs GNCTD & anr, the Board has decided to consider the candidature of Ms Suman in postcode 139/12 instead 138/12 for the post of PGT (History). Further, in view of the fact that the candidate has secured 128.75 marks in Tier-II examination, as such she is considered in zone of selection in OBC Category. Her candidature is kept pending for submission of documents to enable the board to scrutinize her candidature as per RRs for the post. An OBC vacancy has already been kept as pending on account of her representation vide result notice dated 15.03.2017.

The candidature of Ms Asha (26003292) is pending in OBC category in view of her representation which is still being examined by the concerned branch. Further, one vacancy in OBC category is pending in view of representation filed by Ms Pinki Devi (26004187), which is also still being examined by concerned branch

The candidature of candidate having Roll number 26000981 which was earlier kept pending on account of representation filed by Ms Asha



(26003292) in OBC category is hereby considered against the vacancy released.

In view of above and on the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules for the post & the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of PGT (*History*) Female under **Post code 139/2012:**

#The name of candidate is mentioned as Amita in her online form, however in her documents it is mentioned as Amita Dabas/Amita Kumari Dabas. An affidavit in this regard furnished by the candidate is placed in her dossier.

The candidature of candidate having Roll number 26004409 is still pending in UR category for submission of requisite document.

The selection of the above 01 candidate shall be further subject to thorough verification of the candidature of the candidate by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the post or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

The User department shall also check the eligibility of the reservation benefit and verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
