ANNOUNCEMENT

This issue is in continuation of Announcement dated 01.12.2017 vide which the result of Assistant Professors (College Cadre) in the subjects of Economics, English, Home Science and Public Administration was declared. It is hereby announced for the general information to the candidates of English subject that the eligibility of roll number 1178 & 1263 is still under challenge of the Hon'ble High Court in CWP No. 26993/2017 & 26995/2017 respectively. Moreover, the interviews of Roll Number 1178 and 1263 in SC category was conducted provisionally in view of the interim orders dated 28.11.2017 & 27.11.2017 passed by the Hon'ble High Court. Since these writ petitions have yet not been finalized and the eligibility of these candidates bearing roll no 1178 and 1263 is yet to be finalized, so the selection of Roll Number 1178 & 1263 for the posts of Assistant Professors (College Cadre) in the subjects of English under SC category is hereby withdrawn till the final outcome of the aforesaid writ petitions.

Similarly, the selection of Roll Number 1195 in EBP-Gen category for the posts of Assistant Professors (College Cadre) in the subjects of English is also withdrawn till the final outcome of the CWP No. 26915/2017, as the eligibility of another candidate (Petitioner in CWP No. 26915/2017) of the same category is under challenge in the Hon'ble High Court.

Accordingly, the revised result of Assistant Professors (College Cadre) in the subjects of English for SC category and EBP-Gen Category is as under:-
