2. You shall have to produce Medical Fitness certificates issued by the Medical Officer, Chamba duly countersigned by the Chief Medical Officer, Chamba
3. You shall have to produce domicile certificate.
4. You shall have to produce attested copies of certificates showing the date of birth and educational qualification and Caste Certificate etc.
5. You shall have to produce two character certificates, issued by the competent Authority.
6. You shall have to produce certificate to the effect that you have not entered into bigamy.
7. Your appointment will be liable to be terminated at any time without any notice, if your work and conduct is not found satisfactory.
8. Your appointment is also subject to verification of character and antecedents by the police.
9. No TA/DA will be admissible for joining the post.

You are, required to join your duties in the office of Mobile Traffic Magistrate Chamba and furnish the requisite certificates within 15 days from the receipt of this office order, failing which the appointment shall be deemed to have been cancelled.
