5. You shall have to produce character certificate, issued by the competent Authority.
6. You shall have to produce certificate to the effect that he has not entered into bigamy.
7. Your appointment will be liable to be terminated at any time without any notice, if his work and conduct is not found satisfactory.
8. No TA/DA will be admissible for joining the post.

If the above terms and conditions are acceptable to you,you should report for duties in this office and to furnish the requisite certificates within 15 days from the receipt of this offer of appointment,failing which the offer of appointment shall be deemed to have been cancelled.
